Deposits

A non-refundable deposit of \$700.00 is required to secure your reservation. Final payment is due no later than sixty (60) days prior to tour shipping date.

What's Included

Guided motorcycle tour and lodging.

At destination, Experienced Ride America Tour guides conduct daily and multi-day rides along routes that have been previously selected to provide you with an unforgettable experience and memories that will last a lifetime. You are also free to blaze your own trail should you wish to do so. Each tour ends with a group dinner designed for good fellowship and to reinforce friendships made along the way.

What's Not Included

Participants are responsible for their own travel arrangements, both to and from the tour destination, meals, fuel, and all other related expenses.

Important Things:

- Our tours generally coincide with peak seasonal demand. Ride America Tours recommends early booking of your flight arrangements soon after tour confirmation. Should assistance be needed for booking flights, Ride America Tours recommends you contact a travel agent. Travel insurance is available and recommended.
- The tours are scheduled at times when the weather is suitable for motorcycle touring. However, at times the weather may not cooperate; therefore we will not ride in dangerous conditions or severe weather.
- Drinking is not allowed while we are riding. Also, we do not allow firearms or illegal drugs of any kind on or in your motorcycle or in our trailer(s).
- These are not tours for novices or the new beginner nor a place/trip to learn how to ride a motorcycle. It is important to note that you and passenger (if applicable) must be in good physical condition, good health and adapted to riding for long periods during the day.

**ACKNOWLEDGEMENT OF RISK & WAIVER AND RELEASE OF LIABILITY
READ THIS CAREFULLY – IT AFFECTS YOUR LEGAL RIGHTS**

INTRODUCTION:

Ride America Tours, LLC offers a variety of riding conditions for your enjoyment including winding roadways with the possibility of gravel/sand on roadways or even debris on the pavement as well as all types of weather elements. As you know, motorcycle touring exposes you to all types of temperature and climate changes (sometimes we can reach elevations exceeding 12,000 feet) related to the region in which we are touring. With this said, this is not the tour for novices or the new beginner nor a place/trip to learn how to ride a motorcycle. You and passenger (if applicable) must be in good physical condition, good health and adapted to riding for long periods during the day.

AGREEMENT:

THIS AGREEMENT MUST BE CAREFULLY READ AND SIGNED BY THE APPLICANT (AND PASSENGER) IN CONSIDERATION OF BEING PERMITTED TO PARTICIPATE IN A RIDE AMERICA TOURS, LLC MOTORCYCLE TOUR.

I (We) understand that operating a motorcycle is an activity that presents and contains considerable risk of serious personal injury, paralysis, dismemberment, property damage, loss and possible death. **I (We) further understand that riding a motorcycle is subject to both foreseeable and unforeseeable risk and dangers. I (We) hereby knowingly and freely accept the risk of all personal injury and property damage to both myself, my passenger, and to others arising from my (our) participation in a Ride America Tours, LLC Motorcycle Tour.**

I (We) expressly acknowledge and agree that the activities of motorcycle touring are very dangerous and involve risk of serious injury and that this release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the state in which the tour event is conducted and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. **THE UNDERSIGNED HAVE READ AND VOLUNTARILY SIGN THIS RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT.**

I (WE) HEREBY RELEASE, WAIVE, DISCHARGE, HOLD HARMLESS AND AGREE THAT MY (OUR) DEPENDENTS, HEIRS SUCCESSORS, EXECUTORS AND ASSIGNS DO RELEASE, WAIVE, DISCHARGE AND HOLD HARMLESS AGAINST, AND INDEMNIFY RIDE AMERICA TOURS, LLC, ITS OWNERS, EMPLOYEES, OFFICERS, DIRECTORS, AGENTS AFFILIATES AND ASSIGNS (COLLECTIVELY, “RELEASED PARTIES”) FROM ANY AND ALL CLAIMS, WHETHER CIVIL OR CRIMINAL, INCLUDING CLAIMS OF DEATH, BODILY INJURY, ILLNESS, PROPERTY DAMAGE OR LOSS, HOWEVER CAUSED, ARISING FROM OR RELATED TO A RIDE AMERICAL TOURS, LLC SPONSORED MOTORCYCLE TOUR.

A General Release does not extend to claims which the Releasing Party does not know or suspect may exist in his/her favor at the time of executing the Release and, that if known by him/her must have materially affected his/her contract with the Released Party. Being aware of the above, the Releasing Party hereby expressly waives all of his/her rights thereunder as well as any other statutes or common law principles of similar affect of any applicable jurisdiction.

I (We) agree to ride within my riding ability and agree not to be influenced by any group or pack mentality to ride faster than is within my (our) ability, or what is considered to be safe riding conditions. Nor will I (We) be influenced by riding displays by my (our) fellow tour participants nor tour guides that could be considered to be unsafe. I (We) fully understand that I (We) may encounter riding conditions and road conditions that I (We) have not traveled before, have no prior knowledge of, and therefore will ride in a manner that is considered to be safe for those riding conditions.

I certify (driver only) that I am a licensed motorcycle operator and that I hold a current valid state issued motorcycle license and/or endorsement to my driver’s license. I (We) further certify that I (We) am/are in good health and have no mental or physical impairments that may affect my (our) safety or the safety of others.

I (We) understand that I (We) will wear a helmet in the states where it is required by state law, and when in those states where a helmet is optional, I (We) understand the choice of wearing a helmet or not, is solely my (our) own choice.

I (We) understand that Ride America Tours, LLC expressly prohibits the use of any illegal drug or the consumption of alcohol during any of the day tours. Anyone found to have used illegal drugs at any time during the tour, or consumed alcohol the day of the tour or during the tour will be expelled or prohibited from riding the remainder of the tour without a refund of any portion of the tour fee.

I (We) understand that there are many companies offering services similar to those offered by Ride America Tours, LLC and that I (We) are free to sign up for motorcycle tours with any other company offering services similar to those offered by Ride America Tours, LLC.

I (We) acknowledge that Ride America Tours, LLC has no affiliation with any hotel, resort or other source of accommodation to be used on this tour and that Ride America Tours, LLC assumes no responsibility or obligation with regard to any damage or injury attributable to any wrongful or negligent act or omission on the part of any such hotel, resort or other source of accommodation.
